"WELCOME HOME" QUILT



Flora Jo "Peaches" Dunn grew up during the Vietnam War era in a family where military service was commonplace throughout generations. In 2004, merging her craftwork in sewing and an expression of solidarity, she began fabricating a "Welcome Home" quilt for those who served during the Vietnam War. Since the project began, Dunn has received dozens of photographs, uniforms, emblems, and other patriotic mementos. These keepsakes, which have been sent to her from all over the country, were transformed into the patchwork pieces that make up the 51-by-110-inch quilt, which will be presented to *TMW* as a gift.

Working with worn soldiers' uniforms was an especially uplifting part of the process for Dunn, who lives in Tiverton, Rhode Island. The quilt also features military pins and patches, photographic transfers of servicemen, hand-stitched quotes, and keychains with symbolic beads. In one section, Dunn sewed the American flag upside-down – not as a symbol of dissent, but as a sign of a country in distress. The public is also invited to pin memorabilia to the piece. Dunn, who is the recent widow of a Vietnam veteran, crafted the quilt to show veterans her support. "Finally, I can say, Thank you, and Welcome Home," says Dunn.

BRIEF HISTORY

The Moving Wall, a half-size replica of the Vietnam Veterans Memorial in Washington, D.C., was inspired by one soldier's visit for the dedication of the original memorial in 1982. John Devitt, a former helicopter door gunner and Army veteran who served during the Vietnam War, was changed by his experience at the Memorial. He wanted to share that with others across the country who did not have the means to make the trip to the nation's capital to see it with their own eyes. With the help of friends, family, and fellow veterans, Devitt spent two years conceptualizing, financing, and creating *The Moving Wall*.

Today, the monument has been touring for 34 years and has been to more than 1,000 communities across the United States. Devitt, who is dedicated to sharing his vision, wants *The Moving Wall* to be about honoring and remembering the individuals who died serving this country.

THE NEWPORT VISIT

Bringing *The Moving Wall Vietnam Veterans Memorial* to Newport in 2019 is a community effort to honor the many veterans in Newport and throughout all of Aquidneck Island and Rhode Island. *The Moving Wall* has been brought here for every single Vietnam vet, especially those whose stories have gone untold and unnamed for too long. The hope is that the presence of *The Moving Wall* can bring healing, with the acknowledgement that it can never replace sacrifices made or loss of life. Bringing *The Moving Wall* here is a way for this community to say thank you to all Vietnam veterans—for enduring pandemonium, horror, and adversity, and recognizing moments of beauty, kinship, and harmony they may have experienced.

There is an interesting design note that ties the Washington, D.C. monument to Newport's historic harbor area. The Vietnam Veterans Memorial in Washington, D.C. was designed in 1981 by Maya Lin, who was an undergraduate student at Yale University and just 21 years old at the time. Her iconic monument broke with convention, dramatically changing the course of memorial design and typology. Lin, who went on to become an architect, designed "The Meeting Room" in 2013, a permanent installation in Newport's Queen Anne Square, consisting of stone foundations, a water table, and carved quotations that represent the historic uses of the public park. Queen Anne's Square is located just one-third of a mile from Touro Park, an easy walk down Pelham Street toward Newport Harbor.

IN MEMORY PROGRAM

Since the Vietnam War ended, thousands of Vietnam veterans have died each year due to Agent Orange exposure, PTSD/suicide, cancer, and other causes related to their service. The Vietnam Veterans Memorial Fund's (VVMF) In Memory program honors those who returned home from Vietnam and later died.

The plaque on the grounds of the Vietnam Veterans Memorial site in Washington, D.C. that honors these veterans was dedicated in 2004 and reads: "In Memory of the men and women who served in the Vietnam War and later died as a result of their service. We honor and remember their sacrifice."

In Memory was created in 1993 by the group Friends of the Vietnam Veterans Memorial. VVMF began managing the program and hosting a ceremony in 1999. More than 3,600 veterans have been added to the In Memory Honor Roll since the program began.

SPEAKER PROFILES



Rodrego "Rudy" S. Borgueta, Vietnam Veteran

A native of Newport, Rhode Island, Rodrego "Rudy" S. Borgueta enlisted in the United States Marine Corps after graduating from Rogers High School in June 1965 and was recommended for duty with the 1st Air Naval Gunfire Liaison Company (ANGLICO), Fleet Marine Force, Western Pacific. In August 1966, he began an assignment in Vietnam working with the Republic of Korea's Marine Blue Dragon Brigade, located in I Corps within the boundaries of Quang Ngai Province. His total tour with the Republic of Korea Marine Corps totaled 19 months; he was honorably discharged from the U.S. Marine Corps in April of 1969 with the rank of Sergeant. Borgueta's military awards include two Purple Heart Medals; a Vietnam Campaign Medal with two stars; and a South Vietnam Gallantry Cross. He also earned gold Marine Airborne Wings and the Sharpshooter marksman badge and was nominated for the Bronze Star Medal with Combat "V." After leaving the Marine Corps, Borgueta had a 30-plus-year career as a middle and high school educator and administrator, retiring in 2001. He now works as the Club Steward of Newport Yacht Club.



John L. Ciummo, Vietnam Veteran

A resident of Middletown, Rhode Island, John L. Ciummo is a graduate of the University of Rhode Island, where he received Bachelor of Arts degrees in history and political science. He served in the United States Marine Corps from June 1965 through June 1969, and received numerous awards, including the Bronze Star with Combat "V" for valor, two Purple Heart Medals, a Combat Action Ribbon, and a Good Conduct Medal. His professional career spanned 30 years in the chemical industry in managerial positions; he retired in 2013. His current areas of focus include serving on the Middletown, Rhode Island Planning Board, working as a substitute teacher in the Middletown Public Schools system, and working as a Third Beach lot supervisor in the summer. He is married and has two children, Tyler and Shannon.



Paul A. Croce, Vietnam Veteran

Paul A. Croce participated in the Army ROTC program at the University of Rhode Island. Upon graduation in 1962, he received a Bachelor of Science degree in mechanical engineering and was commissioned as a Second Lieutenant in the U.S. Army Corps of Engineers. After receiving a Master of Science degree from the Massachusetts Institute of Technology, he began his active duty service, and in 1966, he was assigned to the 45th Engineer Group, Republic of Vietnam. Captain Croce became the Chief Construction Engineer Officer and oversaw a broad range of Army Engineer construction projects in central South Vietnam. Upon returning home, he left active duty and earned a Doctor of Science Degree in Mechanical Engineering at Washington University in Saint Louis. His professional career includes global scientific research efforts into the various causes of property loss, both natural and man-made, and practical technological solutions for mitigating such losses. He retired as vice president of FM Global in 2005. An editor, author, and technical consultant, he also co-holds a patent for a harsh environment temperature and moisture probe. Croce currently

serves advisory roles at URI; he is a trustee of the Rhode Island Historical Society; and he also chairs the Planning Board of the Town of Middletown.




Daniel Evangelista, Vietnam Veteran

Daniel Evangelista was drafted into the U.S. Army on September 21, 1966, and was discharged on September 14, 1968. He served with the 7th Squadron, 17th Air Cavalry Regiment, assigned to the 4th Infantry Division at Camp Enari in Pleiku, Vietnam, in the Central Highlands. He participated in the Tet Offensive of 1968. After discharge, Evangelista earned a college degree and in July 1974, he became involved with the founding of the Vietnam Era Veterans Association (VEVA) and Rhode Island Veterans Action Center (RIVAC), the first non-profit, community-based agency for veterans. From 2003 until 2015, Evangelista worked with the Rhode Island Division of Veteran Affairs in various positions. Evangelista served in the Rhode Island Army National Guard from 1984 until 2004, and brought the first R.I. Army National Guard unit–the 118th Military Police Battalion–to the First Gulf War as Detachment First Sergeant. For his service, Evangelista has been awarded the Bronze Star for meritorious service, Meritorious Service, National Defense Service, Vietnam Service, and

Southwest Asia Service medals; the Saudi Arabian Medal for the Liberation of Kuwait; and the Rhode Island Star ribbon. He is married to JoAnn Simmons.





Frank L. Grzyb, Vietnam Veteran

Frank L. Grzyb is a U.S. Army combat veteran of the Vietnam War. While in-country, he was awarded a Bronze Star, Purple Heart, and Army Commendation medals, along with several other service medals, campaign ribbons, and citations. Grzyb is the author of several books, including "Touched by the Dragon: Experiences of Vietnam Veterans from Newport County, Rhode Island," with an introduction by U.S. Secretary of State John Kerry (re-released in trade paperback as "A Story for All Americans"); "Ain't Much of War"; "Rhode Island's Civil War Hospital"; "Hidden History of Rhode Island and the Civil War"; "Remarkable Women of Rhode Island" (co-authored with Russell J. DeSimone); and "The Last Civil War Veterans." His work has been featured in magazines such as *Civil War Times, America's Civil War, Civil War Monitor*, and *North & South*. Active on the lecture circuit, Grzyb is also a contributing writer for *The Online Review of Rhode Island History*. He also is a life member of the Vietnam Veterans of America, Military Order of the Purple Heart, and Disabled American Veterans.




Col. (Ret.) Joseph McGraw, USA

Joseph McGraw is an associate professor in the Joint Military Operations Department at the U.S. Naval War College. He first joined the Naval War College faculty in August 2014 following command of a U. S. Army Special Forces Battalion. His prior active duty tours include Commander, Special Operations Task Force-West—Afghanistan; Executive Officer 1st Special Forces Group (Airborne); Deputy Commander, Joint Special Operations Task Force—Philippines; and Commander, Advanced Operating Base 1220—Diyala, Iraq. McGraw is a graduate of the United States Military Academy and the Naval Postgraduate School. He is married to Leigh McGraw (LTC, USA Retired). They reside in Portsmouth, Rhode Island, with their three children, Katie, Tommy, and Sydney.



Kenneth "Buzz" Riley, Vietnam Veteran

Newport, Rhode Island native Kenneth "Buzz" Riley enlisted in the U.S. Marine Corps after graduating from Rogers High School in 1965. He trained at Parris Island, Combat and Cold Weather Training at Camp Lejeune, and Jungle Warfare Training at Camp Pendleton. In June 1966, he left for Vietnam, and was wounded in action on November 15, 1966. He later became Manpower Coordinator for New Visions for Newport County then attended the R.I. Municipal Police Training Academy, graduating at the top of his class in 1974. He then joined the Newport Police Department, leaving in 1982 due to health problems resulting from Agent Orange exposure. A lifetime member of the Military Order of the Purple Heart, he has received Purple Heart, National Defense Service, and Vietnam Service medals; a Republic of Vietnam Gallantry Cross; Vietnam Presidential and Navy Presidential Unit Citations; and the National Purple Heart Hall of Honor. Riley is married to Maureen and has one son, Cavon, and three grandchildren.



Wayne Smith, Vietnam Veteran

A native of Providence, Rhode Island, Wayne Smith is an accomplished veterans' advocate who has worked with war veterans for nearly four decades. After serving nearly 18 months in Vietnam as a combat medic, Smith overcame his own wartime trauma and struggles with substance abuse before becoming a nationally recognized mental health therapist and advocate for war veterans. Smith has played leadership roles in several prominent national organizations, including the Vietnam Veterans of America Foundation, a co-recipient of the 1997 Nobel Peace Prize for its work in the international campaign to ban landmines, and The Black Patriots Foundation, promoting wider recognition of the vital role that African Americans played during the American Revolution. Smith is currently the civil liberties program manager for the Unitarian Universalist Service Committee in Cambridge, Massachusetts. In 1998, Smith returned to Vietnam with 20 American veterans to promote peace and reconciliation. Together with 20 Vietnamese soldiers, these former enemies rode bicycles 1,200 miles, from Hanoi to Ho Chi Minh City, to help heal some of the wounds of that war. Smith was executive director of The Justice Project, which waged a successful campaign leading up to the 2004 passage of the Innocence Protection Act, for federal death penalty reform.



Daniel K. Thurston, Vietnam Veteran

Daniel K. Thurston grew up in Warwick, Rhode Island, in a large family of two girls and six boys. Of the six boys in his family, four are Vietnam veterans. (To his knowledge, that is unique to Rhode Island.) From 1968–1969, he was a proud member of the Fighting Seabees, attached to the United States Marine Corps. Veteran and motorcycle organizations have been his lifelong passion. Fortunately, he has been able to visit the Vietnam Veterans Memorial in Washington, D.C., many times, as well as *The Moving Wall Vietnam Veterans Memorial* when it has visited regionally over the years.



Captain (Ret.) Mark L. Turner, USN

A native of Greenwich, Connecticut, Captain Turner is a graduate of Marquette University. He received his commission through the Reserve Officer Training Corps. He has deployed around the globe in support of Operations Joint Endeavor, Southern Watch, Iraqi Freedom, and Enduring Freedom. In addition to maritime patrol operational tours, he served on the USS George Washington (CVN-73). He qualified as Officer of the Deck, and earned his Surface Warfare Officer designation. Staff tours included the Bureau of Naval Personnel, two tours on the Chief of Naval Operations staff, and a tour on the Joint Chiefs of Staff. He commanded VP-45 and served as Commander, Patrol and Reconnaissance Wing Eleven, NAS Jacksonville, Florida. Upon completion of his major command tour, he attended the Naval War College receiving a Master of Arts degree in National Security and Strategic Studies. He was designated a Burke Fellow and was a recipient of the James D. Forrestal Award for excellence in Strategy and Force Planning. Upon completion of the Seminar XXI program, Captain Turner was designated a Massachusetts Institute of Technology Fellow. He retired in 2017 and currently works as a defense contractor at the U.S. Naval War College.



U.S. Senator Sheldon Whitehouse

Senator Sheldon Whitehouse represents Rhode Island in the U.S. Senate, where he serves on the Budget, Environment and Public Works, Judiciary, and Finance committees, and the Commission on Security and Cooperation in Europe. Growing up in a Foreign Service family, Whitehouse lived in Vietnam, as well as Cambodia, South Africa, Congo, Guinea, Laos, and Thailand. While abroad, he learned firsthand the example American democracy sets for the world. Whitehouse has fought in the Senate on behalf of veterans and current members of our armed forces, including passing into law foreclosure protections for service members leaving active duty. He has been a leading voice in support of funding for the cleanup of Agent Orange–contaminated sites in Vietnam and assistance programs for those afflicted with related health conditions. A graduate of Yale University and the University of Virginia School of Law, Whitehouse served in multiple senior roles in Rhode Island government before his appointment by President Clinton as Rhode Island's United States Attorney in 1994. He was elected Attorney General of Rhode Island in 1998, and to the Senate in 2006. He and his wife, Sandra, live in Newport. They have two grown children.



Former RI Chief Justice Frank J. Williams, Vietnam Veteran

Born in Cranston, Rhode Island, Frank J. Williams received his Bachelor of Arts degree in government and history from Boston University in 1962, then entered the military. Rising to the rank of Captain in the U.S. Army, he saw active duty in Vietnam and served for five years. Among his awards and decorations are the Bronze Star Medal, three Air Medals, an Army Commendation Medal, two Vietnam Campaign Medals, and a Combat Infantryman Badge. He was also decorated by the Republic of Vietnam with – among other honors – the Gallantry Cross with Silver Star for Valor. Williams served as Chief Justice of the Rhode Island Supreme Court from February 2001 to December 2008, and had previously served for five years as Associate Justice of the Superior Court. He now serves as a mediator and arbitrator and volunteers on the Supreme Court's appellate mediation panel. Chief Justice Williams served as a member of the U.S. Court of Military Commissions Review Panel for tribunals to be held in Guantanamo Bay, Cuba, with

the rank of Major General, from 2003–2008. Chief Justice Williams is also one of the nation's leading authorities on the life and times of Abraham Lincoln, and one of the country's most renowned Lincoln collectors. A longtime resident of Hope Valley, Rhode Island, Chief Justice Williams has been married since 1966 to Virginia Elizabeth (née Miller), with whom he has built the Frank and Virginia Williams Collection of Lincolniana at Mississippi State University.



Kasim J. Yarn, Director, RI Office of Veterans Affairs

In 2016, Lieutenant Commander Kasim J. Yarn retired from the U.S. Navy after more than 20 years of military service upon appointment by Governor Gina Raimondo to become Rhode Island's first Director of Veterans Affairs. He reports directly to the governor and is a participating member of the Health and Human Services Secretariat. Yarn grew up in Jackson, Mississippi, and enlisted in the U.S. Navy at the age of 18. While stationed at Naval Station Newport in 1995, he was selected to attend college and become an officer. In 2000, he graduated from Boston University, received his commission as a naval officer, and was deployed aboard the USS Nashville in the Mediterranean area of operations. In 2002, Yarn reported to the USS Biscoe and deployed to the Persian Gulf. After his assignments at sea, he became an instructor at the Surface Warfare Officers School at Naval Station Newport in 2004. While in Newport, Yarn earned a master's degree in National Strategic Studies with a concentration in statistics in 2006 from the U.S. Naval War College. Beginning in July 2007, he served on several deployments with the Navy's Sixth and Fifth Fleets in increasing roles of responsibility. In July 2013, he returned from deployment to become a faculty member at the Naval War College. Yarn and his wife, Rosaria, made Rhode Island their permanent home in 2004; they live with their children, Jonathan and Giovanna, in North Kingstown.

LTC (Ret.) Margaret R. Zarek, USN, Vietnam Veteran
